6. A statement made under penalty of perjury that the information provided is accurate and the notifying party is authorized to make the complaint on behalf of the copyright owner.

*Once Proper Bona Fide Infringement Notification is Received by the Designated Agent:* It is AYSON's policy:

1. to remove or disable access to the infringing content;

2. to notify the content provider, member or user that it has removed or disabled access to the content; and

3. that repeat offenders will have the infringing content removed from the system and that AYSON will terminate such content providers, member's or user's access to the service. *Procedure to Supply a Counter-Notice to the Designated Agent:* 

If the content provider, member or user believes that the content that was removed or to which access was disabled is either not infringing, or the content provider, member or user believes that it has the right to post and use such content from the copyright owner, the copyright owner's agent, or pursuant to the law, the content provider, member or user must send a counter-notice containing the following information to the Designated Agent listed below:

If a counter-notice is received by the Designated Agent, AYSON may send a copy of the counter-notice to the original complaining party informing that person that it may replace the removed content or cease disabling it in 10 business days. Unless the copyright owner files an action seeking a court order against the content provider, member or user, the removed content may be replaced, or access to it restored, in 10 to 14 business days or more after receipt of the counter-notice, at AYSON's discretion.
